CHAPTER 65

HEADGEAR AND PARTS THEREOF

NOTES

1. This Chapter does not cover:

- (a) worn headgear of heading 6309;
- (b) asbestos headgear (heading 6812); or
- (c) dolls' hats, other toy hats or carnival articles of Chapter 95.

2. Heading 6502 does not cover hat-shapes made by sewing, other than those obtained simply by sewing strips in spirals.
