CHAPTER 51

Wool, Fine or Coarse Animal Hair; Horsehair Yarn and Woven Fabric

NOTE

1. Throughout this Schedule:

(a) "Wool" means the natural fibre grown by sheep or lambs;

(b) "Fine animal hair" means the hair of alpaca, ilama, vicuna, [1](#) [camel (including dromedary),] yak, Angora, Tibetan, Kashmir or similar goats (but not common goats), rabbit (including Angora rabbit), hare, beaver, nutria or musk-rat;

(c) "Coarse animal hair" means the hair of animals not mentioned above, excluding brush-making hair and bristles (heading 0502) and horsehair ([2](#) [heading 0511]).
