Section 31 - AMENDMENT OF SECTION 55 In section 55 of the Income tax Act,-in sub-section

2), with effect from the 1st day of April, 2004,- (a) in clause (ab), for the word "corporatisation", the words "demutualisation or corporatisation" shall be substituted; (b) after clause (ab), the following proviso shall be inserted, namely:- "Provided that the cost of a capital asset, being trading or clearing rights of the recognised stock exchange acquired by a shareholder who has been allotted equity share or shares under such scheme of demutualisation or corporatisation, shall be deemed to be nil;".
