2. 29.07.2013 In this application, the petitioner has prayed for disposal of W.P.(S) no.2437 of 2013 in terms of the order passed in in W.P.(S) no.3910 of 2012[Prabhaker Kumar & Anr. Vrs. State of Jharkhand & Ors.]. Learned counsel for the petitioner submitted that the matter involved in the writ petition is entirely similar to the matter involved in W.P.(S) no.3910 of 2012 and, as such, the writ petition be disposed of in terms of the said order. Learned J.C. to G.P.VI, appearing on behalf of the respondents, has not disputed the said contentions and submitted that the writ petition can be disposed of in terms of the order passed in W.P.(S) no.3910 of 2012. Considering the above, this application is allowed. The writ petition is being disposed of by a separate order. I.A. no.5072 of 2013 stands disposed of. (Narendra Nath Tiwari, J.) s.b. Narendra Nath Tiwari For the Petitioner : Mr. R.P.Srivastava, Advocate For the Respondents : J.C. to G.P.VI ----- 3/29.07.2013 In this writ petition, the petitioner has prayed for a direction on the respondents to consider his representation regarding grant of benefit of MACP floated by the State Government by Resolution no.2981 dated 01.09.2009. It has been stated that the petitioner was appointed on the post of Assistant Teacher in Government Basic School on 29.06.2001. The petitioner, thereafter, continuously worked for more than ten years. According to the policy decision of the Government, the petitioner is entitled to get the benefit of pay upgradation under Modified Assured Career Progression Scheme(MACP) on completion of continuous service of ten years. The petitioner filed representation before the concerned authority praying for grant of benefit of MACP, but the same has not been heeded upon. Learned J.C. to G.P.VI, appearing on behalf of the respondents, submitted that if the petitioner's representation is still pending or if he files fresh representation regarding his grievance, the same shall be considered and appropriate order shall be passed. It has been informed that the Regional Deputy Director of Education, South Chhotanagpur Division, Ranchi is the competent authority in the matter. Considering the said submission, this writ petition is disposed of giving liberty to the petitioner to file fresh representation regarding his grievance before the Regional Deputy Director of Education, South Chhotanagpur Division, Ranchi-respondent no.5. On receipt of the representation, the said respondent shall consider the same and pass appropriate order in accordance with law, within six weeks from the date of receipt of representation. If the petitioner is found entitled to get the benefit, as claimed by him, admitted amount of arrears shall be paid to the petitioner with statutory interest, within six weeks thereafter. If the amount found payable to the petitioner, is not paid within the said period, the petitioner shall be entitled to get compensatory interest @ 10% per annum from the date the amount found payable till the date of final payment.
