It is submitted by counsel on both sides that all the issues between the parties have been settled and that a joint petition has been filed before the Family Court, Ernakulam.

I.A.No. 3297 of 2012 has been filed by the respondent husband for lifting the attachment which is subsisting over the immovable property described in plaint 'A' schedule properties as per I.A.No. 1080 of 2003 in O.P. No. 341 of 2003 of the Family Court, Ernakulam. This is necessary, according to counsel on both sides, so as to enable the husband to raise the sum of Rs. 30,25,000/-, which he is eligible to pay to the wife for implementing the settlement. There is no objection to the application for being allowed. Hence, we allow I.A.No.3297 of 2012 and lift the attachment in respect of the plaint 'A' schedule property alone.
