This petition is filed under Section 438 of Cr.P.C. for anticipatory bail.

2. Heard the learned counsel appearing for the petitioners and the learned Public
Prosecutor appearing for the respondents.

3. Learned counsel for the petitioners submits that the petitioners apprehend
arrest by Karunagapally Police on an accusation of having committed a non
bailable offence. He further submits that the petitioners have not committed any
offence at all.

4. Learned Public Prosecutor, on instructions, submits that no case has been
registered by Karunagapally Police against the petitioners. Therefore, the
apprehension of the petitioners that they would be arrested by Karunagapally
Police has no basis. In view of the submissions so made by the learned Public
