No. 3833/2011 filed for a direction to prohibit defendants 2 to 6 from disbursing any amount from the deposits in the banks. (ii) I.A. No. 3835/2011 filed for a direction to defendants 2 to 6 to produce certain documents, records and ledgers. (iii) I.A. No. 1701/2012 filed for a direction to appoint a qualified Chartered Accountant to conduct an audit of the accounts.
