ORDER

In this petition under Section 438 of Cr.P.C, the 2nd accused in Crime No.112/2013 of Peramangalam Police Station for offence under Sections 341, 323 and 326 r/w 34 of IPC, seeks an order directing the 2nd respondent to release the petitioner on bail, in the event of arrest with a plea that the petitioner is falsely implicated.

2. It is submitted by the learned counsel for the petitioner that the 1st accused was arrested and released on bail.

3. In the above circumstances, this petition is disposed of directing the petitioner to surrender before the Investigating Officer on or before 11.2.2013. The Investigating Officer after arrest and interrogation, if any, shall produce the petitioner before the Magistrate concerned, so as to enable the petitioner to apply for bail. In the event of the 1st petitioner was granted bail, the petitioner shall also be released on bail, on the same terms and conditions. P.S.GOPINATHAN Judge
