JUDGMENT

These Original Petitions are filed by the 1st appellant in A.S. No.100 of 2012 and the appellant in A.S.No.79 of 2012 pending in the First Additional District Court, Mavelikkara. Prayer in these Original Petitions is for a direction to the learned Additional District Judge for speedy disposal of those appeals.

2. Learned counsel submits that the dispute involves framing of a Scheme and Thanthric right of Harippad Subramanya Swamy Temple. It is submitted that early disposal of the appeals is required.

3. Since the appeals are of the year 2012, I do not think it necessary to issue any direction for early disposal. However, this judgment will not stand in the way of petitioner impressing learned First Additional District Judge, Mavelikkara of the need to dispose of the appeals as early as possible.
