JUDGMENT The petitioner has approached this Court with the following prayers: "

i) Issue a writ of mandamus or any other appropriate writ order or direction to direct the respondents to allow the petitioner use the puraboke land as way for ingress and egress to his property in Sy.No.336/6 and 192/11 of Aanjoor Village,

Thrissur Taluk. ii) Issue writ of mandamus or other appropriate writ or direction to direct the 2nd respondent to dispose of Ext.P11 representation as early as possible." 2. When the matter is taken up for consideration, the learned counsel for the petitioner submits that the grievance of the petitioner has also been projected by way of Ext.P11 representation, which is pending consideration before the 2nd respondent and that the petitioner will be satisfied if a direction is given to the said respondent to consider and dispose of the same within a reasonable time. W.P.C. No. 19015 of 2013 -2- 3. Heard the learned Government Pleader appearing for the respondents.

4. Considering the limited nature of relief sought for, this Court does not find it necessary to go into the merits of the case. In the said circumstance, the writ petition is disposed of, directing the 2nd respondent to consider and pass appropriate orders on Ext.P11 in accordance with law, after giving an opportunity of hearing to the petitioner at the earliest, at any rate, within 'two months' from the date of receipt of a copy of this judgment. The petitioner shall produce a copy of the judgment along with a copy of the writ petition before the 2nd respondent for further steps P.R. RAMACHANDRA MENON, JUDGE. kp/-
