SURYA KANT, J.

[ORAL].The appellant State of Punjab impugns the order dated 22.03.2013 passed by Central Administrative Tribunal, Chandigarh Bench, Chandigarh whereby it has been directed to open the 'sealed cover' for promotion to the post of Additional Principal Chief Conservator of Forests in the Punjab Cadre of Indian Forest Service and take a final decision on the report furnished by the Inquiry Officer in the matter of charge-sheet dated 19.06.2009.

Financial Commissioner and Principal Secretary to Government of Punjab, Department Forests and Wildlife Preservation has filed an affidavit dated 30.08.2013/02.09.2013, which reads as under:- 1.

That pursuant to dropping of the charge-sheets against respondent No.1, the 'sealed cover' for his promotion to the rank of Additional Principal Chief Conservator of Forests has been opened.

That the case for promotion of respondent No.1 to the rank of Additional Principal Chief Conservator of Forests will be expeditiously examined and decided by the competent authority as per the relevant Rules and Guidelines on the subject.Mr.Amit Singh, learned Additional Advocate General, Punjab, states that given two months' time, the process of promotion shall be completed.

We are, however, of the view that since the sealed cover has been opened, the follow-up action can be taken and concluded by 30th September, 2013.

Ordered accordingly.

Writ petition stands disposed of in the above terms.Dasti.
