## ORDER

This is a petition filed under Section 482 of Cr.P.C. seeking to have the final report quashed.

2. The contention raised by the petitioner is that the non completion of Villas which gave rise to the complaint under the crime thereof is now completed as could be seen from the photographs produced along with this petition and also from the

scene mahazar prepared by the Police. Accordingly, it is contended that the offence will not lie.

3. The final report has been filed, the cognizance has been taken and summons has been issued to the petitioner who is the first accused. In the light of the materials now available, if no offences are made out, the proper remedy for him is to seek a discharge before the appropriate court.

4. Reserving the liberty of the petitioner to move for discharge, this petition is disposed of. If the petitioner wants CrI.M.C No. 5619 of 2013 -2- exemption from personal appearance, he may move application before that court which too shall be considered in accordance with law.
