JUDGMENT

The complaint of the petitioner is that, he has not been granted an electric connection though he had sought for the same on 28.11.2012. The petitioner had purchased an item of property in the year 2011. He has constructed an industrial shed in his property for the manufacture of paper pulp products. Though he had submitted an application for the grant of an electric connection, he complains that the same has not been provided so far. Standing Counsel for the Kerala State Electricity Board appears for the 1st respondent. According to Advocate Sajeev Kumar K.Gopal, the application of the petitioner is not in the prescribed format. Therefore, he has been directed to submit an application in the proper form. He has also to pay the necessary fees for the charges of infrastructure development. The 1st respondent is ready to process his application if the above formalities are complied with. W.P(c) No.7946 of 2014-P22. The learned counsel for the petitioner submits that the petitioner is ready and willing to comply with the said formalities. In view of the above submission, this Writ Petition is disposed of directing the petitioner to comply with the conditions stipulated by the 1st respondent and further directing the 1st respondent to process the application of the petitioner and to pass necessary orders for providing electric connection to the petitioner on his complying with the conditions stipulated.
