-*- Applicants-appellants no.2 & 3 Ajaib Singh @ Jaiba and Gurmail Ram @ Gej have preferred this application seeking suspension of sentence, during the pendency of this appeal.

Applicants-appellants Ajaib Singh @ Jaiba and Gurmail Ram @ Gej have been convicted and sentenced to undergo rigorous imprisonment for a period of 06 years under Section 307 IPC.

The counsel for the applicants-appellants states that the applicants are in custody since 02 yeaRs.03 months and 10 days.

It is stated that Co.accused Parminder Kumar @ Pindi's application for suspension of sentence was allowed and they seek parity.

The custody certificates filed by the State are taken on record.

The sentence mentioned in the custody certificates is rigorous imprisonment for 07 years. It appears that there is a typographical mistake.

The judgment available on the record shows that the accused were sentenced to undergo rigorous imprisonment for a period of 06 years under Section 307 IPC.

Out of 06 years, applicant-appellant no.2 Ajaib Singh @ Jaiba has undergone 02 years, 03 months and 10 days whereas applicant-appellant Gurmail Ram @ Gej has undergone 02 years, 03 months and 02 days.

It will take some time to mature for final hearing.

Without commenting upon the merits of the case, the sentence imposed by the trial Court upon applicants- appellants no.2 & 3 Ajaib Singh @ Jaiba and Gurmail Ram @ Gej stand suspended during the pendency of this appeal and they are ordered to be released on bail on execution of bail and surety bonds to the satisfaction of the Chief Judicial Magistrate/Duty Magistrate, S.B.S.Nagar.

The application stands allowed.
