2. Allegations against the petitioners are that petitioners had assured the complainant for securing Government jobs against consideration.

s are alleged to have taken a total sum of Rs.6 lakhs from the BAIL APPLN. 2061/2017 & 2063/2017 Page 1 of 2 complainant and his associates.

3. The parties had settled their disputes on 20.09.2017 and it is alleged that petitioners have refunded the entire amount of Rs.6 lakhs received from the complainant and the associates.

s were granted interim protection by order dated 25.04.2018 subject to joining investigation.

5. Learned APP under instructions submits that petitioners had joined investigation and investigation is nearly complete and there is no further requirement of the petitioners to join investigation as investigation qua their role is complete.

6. Keeping in view the facts and circumstances of the case and without commenting on the merits of the case and on perusal of the record, I am of the view that petitioners have made out a case for grant of anticipatory bail.

7. Accordingly, it is directed that in the event of arrest, the arresting officer/IO/SHO shall release the petitioners on bail on their furnishing a bail bond in the sum of Rs. 15,000/- each with one surety each of the like amount to the satisfaction of the arresting officer/Investigating Officer/SHO concerned.
