ORDER

A.Muhamed Mustaque, J.

These batch of review petitions arise from a common judgment

of this Court dated 13/4/2023. The matter is related to selection to the post of Constable (General Duty) in Central :-84:- Armed Police Forces, NIA, Secretariat Security Force and Rifleman (General Duty) in Assam Rifles which are para Police Forces and Armed Forces (referred hereinafter as police/armed forces for short).

2. The Staff Selection Commission issued a notification

for filling up 60210 of vacancies in Police/Armed forces in the country. This Court dealt with vacancies earmarked for the State of Kerala. The matter gained the attention of a learned Single Judge in a challenge made by the candidates who suffered rejection on medical grounds. The learned Single Judge granted stay of finalisation of the list which in effect resulted in

selection of the candidates for PAN India. Thereafter, the order

was modified to keep apart 200 vacancies to accommodate those who had approached the Court. Thereafter, the learned Single Judge disposed the matter (W.P.(C).No16131/2020 and connected cases) on 7/4/2021 by ordering Review Medical Examination (RME) to assess their fitness and proceed based on result of RME. There is yet another batch of writ petitions complaining delay in the selection process and pointing out large number of vacancies remaining unfilled. This batch of writ petitions was disposed :-85:- ordering publication of results and this Court directed to fill up the available vacancies by successful candidates.

3. Union of India came in appeal challenging these

judgments. The challenge was on the ground that Union of India cannot take up the recruitment for the alleged vacancy of 243 and odd posts as it would derail the

entire selection process already completed. It was contended that the direction in the

judgment would amount to interfering with the selection process

completed by the Staff Selection Commission. The Division bench at the outset noted that these directions would compel a party to perform an impossible act. Taking note of the fact that these unemployed youth will be left out of future, had a more sympathetic consideration, and directed the Staff Selection Commission to report unfilled vacancies without disturbing the concluded selection, through a sealed cover. In a sealed cover, the Staff Selection Commission provided details of possible selection of 73 to 83 fresh candidates. Therefore, based on the information provided in the sealed cover, this Court disposed the appeals directing the Staff Selection Commission to consider 73 to 83 candidates for appointment and further ordered that the -:86:- earlier selection shall be considered as concluded and conclusive.

4. Heard the learned counsel for the review petitioners and the learned Deputy Solicitor General of India.

5. The review petitions are filed by many candidates who

are not party to the earlier proceedings and who are party to the proceedings pointing out that large number of NJD and ex- servicemen vacancies exist, and further pointing out that this Court committed an error in accepting sealed cover information. They pointed out that there exists more than 305 vacancies by way of NJD and ex-servicemen vacancies and there is absolutely no embargo to include those candidates for those vacancies. They further claim that they will not claim any seniority in the service, and they be treated as junior-most.

6. The question mooted in review is as to the number of

vacancies accepted by this Court and to give further direction to the Staff Selection Commission to include candidates in respect of the vacancies pointed out by them. It is to be noted that in the judgment under review this Court never intended

to -:87:- disturb the selection process already concluded nor this Court had intended to ascertain the number of vacancies so as to give a direction to the Staff Selection Commission. This Court in the judgment itself noted that it was not a matter for this Court to direct the Staff Selection Commission to expand the list after the selection process had been concluded, and proceeded to have a sympathetic consideration based on the admission made by the Staff Selection Commission as to the number of vacancies in which candidates can be considered without disturbing the earlier selection process. In other words, this Court never accepted the directions given by the learned Single Judge but in fact interfered with the direction given by the learned Single Judge. Merely for the reason that this Court had accepted the sealed cover does not mean that this Court had intended to modify the direction given by the learned Single Judge but rather it was left to the Staff Selection Commission to consider those candidates on their own admission. Thus, the Division Bench refused to undertake any exercise as directed by the learned Single Judge. In such circumstances, now in review, this Court cannot undertake any other exercise which this Court in the -:88:-

judgment under review had refused. Accordingly, the review

petitions are dismissed.

7. W.P.(C).Nos.1205/2024, 1252/2024 & 1495/2024:

These writ petitions are filed by candidates who applied for the post of Constable (GD) based on the notification dated filled in accordance with the notification dated 21/7/2018. We have already dismissed the review petitions as we cannot direct the Staff Selection Commission to consider more appointments than admitted by them before this Court. In light of the dismissal of the review, these writ petitions also fail and are accordingly dismissed.
