JUDGMENT

A.Muhamed Mustaque, J.

These matters are related to claim for appointments in the Vikram Sarabhai Space Centre (VSSC), for the category of persons whose properties were acquired for establishment of VSSC.

2. Late Vikram A.Sarabhai was the Chairman of the Indian

Space Research Organisation in the year 1970.

evictees of the land taken over for establishment of VSSC to give special consideration of evicted persons including their descendants falling within three generations, for employment in -:6:- VSSC. It is specified that qualified persons from among the evicted families will be given special consideration and

preference, while recruiting candidates for appointment in VSSC and, this will be subject to recommendation of appropriate Selection Committee. That means, those who are qualified in accordance with the recruitment rules will have preference in the matter of employment. It was specifically agreed in the meeting that special consideration will be given only to those who are having acceptable qualification.

3. The original petitions are filed by applicants before the Tribunal. Their claim for appointment under the evictee category was negated by the Tribunal.

4. In O.P.(CAT).No.108/2014, Union of India and VSSC challenge an order of the Tribunal allowing an application made

by the applicant against rejection of her

she applied for appointment in VSSC. Her claim was

relaxation of three years is given to her, as she belongs to backward community, she cannot be considered as she had crossed the age limit. However, Tribunal found that she could claim for the post only after establishing that she was the legal heir of Francisca Fernandes through a civil suit and therefore, delay was occasioned.

5. We note that there is no dispute to the fact that age limit was 25 years which is relaxable by three years for backward community under OBC category. When she applied for

the post, she had crossed the age limit. It may be true that through civil suit she could claim as a legal heir and the delay might have occasioned due to delay in those proceedings. However, nothing prevented her from applying within time. The Tribunal could not have ordered appointment violating rules regarding age limit for such appointment. Therefore, we are of -:8:- the view that the impugned order has to be set aside and O.P. (CAT).No.108/2014 has to be allowed.

6. The petitioner in O.P.(CAT).No.69/2019, Shri Deepu D. submits that his mother Smt.S.Ushakumari is the daughter of Shri V.Sadanandan and Sadanandans land was acquired for VSSC and that his mother was not given employment. The Tribunal found that the applicant was considered multiple times for

appointment to the posts of Catering Attendant

Fireman-A, he was not found fit in the medical test; and for the post of cook, he did not respond to the intimation given. If the petitioner was found unfit by the Medical Board and also not qualified by the Selection Committee, the petitioner cannot get any benefit. Therefore, this original petition has to be dismissed.

7. In the matter of O.P.(CAT).No.89/2019, the

petitioners are three in number. They pressed their claim for third time. On all occasions, their claim were considered for different Group-D posts of Office Attendant-A, Safaiwala-A and :-9:- Fireman-A, but they were found not successful. It is to be noted that during the selection process, some other persons had to be selected from other categories, two among the three petitioners were found over aged and the other was found not

qualified. Tribunal found that there was a ban in recruiting for the post of Fireman-A only to be dismissed.

8. In the matter relating to O.P.(CAT).No.74/2019, the

Tribunal, by the Ext.P2 order in O.A.No.101/2019 found that on similar set of facts and circumstances, the claims of the applicants in O.A.No.1021/2016 and O.A.No.763/2018, who are the

petitioners in O.P.(CAT).89/2019 and O.P.(CAT).No.69/2019 respectively were dismissed by the Tribunal, and therefore, the Tribunal dismissed the claim of the petitioner herein. We are of the view that, it cannot be reopened by another original petition. Therefore, this original petition is liable to be dismissed. :-10:-

9. Accordingly, we order that O.P.(CAT).No.108/2014 is allowed setting aside the impugned order; and O.P. (CAT).Nos.69/2019, 74/2019 and 89/2019 are dismissed in the light of the above observations.
