JUDGMENT

(Dated this the 1st day of April, 2024) The petitioner is an Anganwadi Worker in Anganwadi Centre No.133 known as Agilandam Anganwadi . By Ext.P1, the petitioner has now been transferred to Paroppadi Sneha Anganwadi. The said order is dated 15/03/2024. The petitioner was directed to join duty within three days. The case of the petitioner is that the petitioner met with an accident on 17/05/2023 and sustained a fracture of her leg and she had to undergo hospitalization and because of the said fact the petitioner was unable to join the present Anganwadi which is 9 Km away from the house of the petitioner. Therefore she filed Ext.P4 representation before the District collector on 21/03/2024 to cancel the transfer and to retain her in the present Anganwadi.

2. Ext. P4 is a representation filed by the petitioner

before the District Collector and Ext.P9 before the Respondent No.3, since Ext.P9 is directed to be disposed of Respondent No.2. The petitioner shall file a representation similar to Ext.P4 before the Respondent No.2 who shall consider Ext.P9 and the said representation and pass appropriate orders within 10 days from the date of receipt of a copy of this judgment.
