ORDER

The petitioner in all these transfer petitions is the wife. The respondent in Tr.P.C.Nos.900 & 902 of 2023 and 1st respondent in Tr.P.C.No.901 of 2023 is the husband.

2. All these transfer petitions have been filed by the wife to transfer three cases pending between the petitioner and the respondent at the Family Court, Kollam as O.P.HMA No. 916/2018, O.P.(Others) No.

3. I have heard the learned counsel for the petitioner. There is no appearance for the respondent in spite of the receipt of notice.

4. At the time of the institution of the above mentioned original

petitions, the Family Court, Paravoor was not constituted. It was constituted subsequently. The petitioner is residing at Meenadu village, which is just 5 kms away from the Family Court, Paravoor. It is settled that while considering the transfer petitions involving family disputes, the convenience of the wife has to be given predominance. Considering all these facts, all these transfer petitions are allowed. O.P.HMA No. 916/2018, O.P.(Others) No. 173/2023 and O.P.HMA ..6..
