JUDGMENT

These writ petitions are connected and therefore, I am disposing these writ petitions by a common judgment:

2. The short point raised in these writ petitions is that

whether broken service of the petitioners can be reckoned for the purpose of pensionary benefits. As per G.O.(MS). No.401/2019/Fin. dated 28.10.2019, Government ordered that the broken spells of provisional service/leave vacancy service rendered by regular aided school staff/Government employees, in aided schools prior to their entry in regular service shall not be reckoned as qualifying service with effect from 10.08.2018. That means the broken service of those who retired from service before 10.08.2018 can be reckoned for the purpose of pensionary benefits. Therefore, these writ petitions are disposed of declaring that

the broken service of the petitioners can be reckoned for the purpose of pensionary benefits. Necessary orders will be passed by the competent authority among the respondents and disburse the consequential benefits to the petitioners, if not already disbursed, as expeditiously as possible, at any rate, within three months from the date of receipt of a stamped certified copy of this judgment. The petitioners will produce a stamped certified copy of this judgment along with a copy of this writ petition before the respondents for compliance. Sd/-
