JUDGMENT

These writ petitions are connected and therefore, I am disposing these writ petitions by a common judgment. Similar

writ petitions were disposed by this Court as per judgment

dated 16.03.2023 in W.P.(C). No.40660/2016 and connected cases. It will be better to extract the above judgment: These writ petitions are connected and therefore, I am disposing these writ petitions by a common judgment.

2. I will narrate the facts in W.P.(C). No.6568 of

2018: Petitioners approached this Court aggrieved by the demand of property tax by respondents 2 and 3 regarding the financial year starting from 2013-14 to 2016-17. According to the petitioners, they remitted the entire property tax as demanded by the Municipality at the relevant time for those years. The petitioners remitted property tax as required by law to the 2nd respondent Municipality till 2016-17 is the submission. It is also the

case of the petitioners that they are ready to remit the property tax for the year 2017-18 as demanded by respondents 2 and 3. It is also submitted that most of the buildings owned by the petitioners are accommodated either by their own business concerns or given on rent to tenants. According to the petitioners, all the rooms of the petitioners are occupied and various business activities are being conducted legally, after obtaining valid permission/license from respondents 2 and 3 as required under the provisions of the Kerala Municipality Act and the Rules. It is the case of the petitioners that the 2nd respondent Municipality has not adopted any resolution enhancing the basic property tax rates with regard to the buildings, situated within the municipal area after 2013. No resolution whatsoever has been adopted to enhance the existing property tax rate in the 2nd respondent Municipality. It is also the case of

the petitioners that no notice as required under Rule 4(2) of the Rules was ever been published or notified by the Municipality. No resolution as required under Section 233(3) of the Act has been ever taken by the Municipality. In such circumstances the demand is illegal is the contention. In some of the writ petitions, the local authorities submitted that the resolutions were already passed by the local authorities and the demands were made as per law.

3. Today, when the matters came up for

consideration, the counsel for the petitioners takes me through Ext.R3(e) produced in W.P.(C). No.6568/2018. It will be better to extract Ext.R3(e) Government Order:

4. In the light of the above Government Order, it

is clear that the property tax can be reviewed only with effect from 01.04.2016. If that be the case, the impugned orders in these writ petitions can be set aside and the local authority concerned can be allowed to take appropriate steps in accordance with Ext.R3(e). All other contentions raised by the petitioners in these writ

petitions can be left open. Therefore, these writ petitions are disposed of in the following manner:

1. In the light of Ext.R3(e) in W.P.(C). No.6568/2018 [G.O.(Rt) No.540/2019/LSGD dated 06.03.2019], all the impugned demand notices and demand are set aside.

2. Local authorities are free to take appropriate

steps in accordance with G.O.(Rt) No.540/2019/LSGD dated 06.03.2019. If the petitioners are aggrieved by the fresh demand notice issued by the local authorities as per G.O.(Rt) No.540/2019/LSGD dated 06.03.2019, they are free to challenge the same in accordance with law.

2. In the light of the above judgment, I think these

writ petitions also can be disposed of. Therefore, these writ petitions are disposed of in tune with the judgment dated 16.03.2023 in W.P.(C). No.40660/2016 and connected cases, in the following manner:

1. In the light of G.O.(Rt) No.540/2019/LSGD dated 06.03.2019, all the impugned demand notices and demand are set aside.

2. Local authorities are free to take appropriate

steps in accordance with G.O.(Rt) No.540/2019/LSGD dated 06.03.2019. If the petitioners are aggrieved by the fresh demand notice issued by the local authorities as per G.O.

(Rt) No.540/2019/LSGD dated 06.03.2019, they
