## **JUDGMENT**

**Sophy Thomas, J.**

The Mat.Appeal is filed by the wife against the judgment in OP No.308 of 2018, dismissing her claim for gold ornaments and money. RP(FC) No.169 of 2021 is filed by the husband, challenging the quantum of maintenance ordered by the Family Court, to the wife and children in MC No.110 of 2017. RP(FC) No.234 of 2021 is filed by the wife and children contending that, the maintenance amount awarded by the Family Court is not inadequate.

2. Pending proceedings, we directed the parties to appear

before us, to try for a settlement. The husband and his brother, who were present before us, agreed that, for settling all the pending disputes between the parties, they could give Rs.12 lakh to the wife and children which would cover the maintenance amount also. The wife is amenable to receive that amount in full and final settlement of all the claims pending between parties including maintenance to the wife and children. Mat.Appeal No.624 of 2021 & 8 In the result, setting aside the impugned judgment and order, the Mat.Appeal and RPFCs are disposed of, directing the respondents to pay Rs.12 lakh to the appellant Smt.Ramsia within a period of six months from today, which covers the maintenance claim of the appellant and children. In default of payment of that amount within six months, the appellant can get it recovered from the respondents and their assets with 9% interest per annum from the date of default till realisation. The Mat.Appeal and RPFCs are disposed of accordingly. No
