JUDGMENT

The petitioners in all these cases are stated to be working as contingent sanitation workers, or in such other ancillary posts, in the services of Thiruvnanthapuram Municipal Corporation ('Corporation' for short).

2. Some of the petitioners assert that the Corporation has

already taken a decision to regularise them in service; while the others seek that their cases be also directed to be considered by the said Authority, without any further delay, particularly because they have been serving it for the last several years.

3. There is another set of petitioners in these cases, namely,

those in W.P.(C).No.10982/2018 and W.P.(C).No.41289/2018, who allege that, even though they have been sponsored by the Employment Exchange and were called for interview by the Corporation for being appointed permanently, said processes had been disrupted by others who were in service; and thus that they have now been accommodated only on daily wage basis, or : 35 : contingent/substitute basis.

4. That said, the common request of all the petitioners in

these cases is that Corporation be directed to consider all of them for permanency/regularisation because vacancies are still available and since the Government of Kerala has already issued orders directing a seniority list of persons to be prepared, so as to be then advised for appointment permanently against such, or to the vacancies to arise in future. They thus pray that Corporation be directed to do so without any avoidable delay.

5. In response, the learned Senior Government Pleader -

Smt.Mable C.Kurian, conceded that Government has issued certain orders with respect to contingent workers and that the Corporation is expected to act as per its terms. She pointed out that one of the said orders is to the effect that all persons will have to be appointed only on being sponsored by the Employment Exchange, but only as contingent/substitute workers; and that a list of such persons will have to be prepared by the Corporation, so as to be considered for appointment when permanent vacancies arise or are available. She added that once the Corporation does it in terms of the applicable Government orders, they will have to place the list before the Government for concurrence and approval, subsequent : 36 : to which alone, petitioners can be offered any benefit.

5. The learned Standing Counsel for the Corporation -

Sri.Suman Chakravarthy, submitted that his client has no objection in preparing the list of contingent workers in their services, including the petitioners, if they are so entitled; and to place it before the Government for its approval. He prayed that, at least four months time be granted to his client for this purpose.

6. When I evaluate the afore rival submissions, it is evident

that petitioners are still continuing to work on contingent basis, or on substitute basis, or on daily wage basis, as the case may be. Their request for permanency or regularisation certainly can be considered and acceded to only as per the Government orders that hold the field, which appear to mandate that a list of such persons created by the Corporation, depending upon their seniority in service. It is only after this is done, in terms of the mandate of the instructions issued by the Government, can the petitioners obtain any right for their claims to be considered.

7. It is no different for the petitioners in W.P.(C).Nos.

that they were sponsored by the Employment Exchange for permanent engagement, since they unequivocally admit that they : 37 : were appointed only as contingent/substitute workers, and that they had accepted such, their claims can be considered as that of any other candidate. In the afore circumstances, I dispose of these writ petitions in the following manner:

(a) The competent Authority of the Corporation is

directed to prepare a list of Contingent Workers/ Substitute Workers on their Roll, following the manner instructed by the Government in their applicable Order, as expeditiously as is possible, but not later than four months from the date of receipt of a copy of

this judgment

(b) While the afore exercise is completed, the

Corporation shall also first prepare and publish the Draft Seniority List; and if the petitioners, or any other person, has any objection to the same, they will be at liberty to make them known to the Corporation, which shall then be considered before finalising the Final Seniority List.

(c) On the Seniority List being so finalised, the

Corporation will forward the same to the Government : 38 : for approval and necessary action; which shall then be considered and necessary instructions issued within a period of three months thereafter. The claims of the petitioners will thereupon be decided by the Corporation in terms of their rank in the seniority list and will be accommodated against the vacancies, as per the instructions to be given by the Government, without any avoidable delay thereafter. Needless to say, until such time as the afore exercise is completed and the resultant orders communicated to the petitioners, they will be allowed to continue in service as on the same terms, as of now. It is needless to say that, I have not considered any of the other rival contentions of the parties and that they are all left open to be impelled in the future, if it becomes so warranted.
