JUDGMENT

These Writ Petitions have been filed by either students or teachers, in support of conduct of Distance Education Programs by the various Universities in Kerala.

2. I do not propose to write a long judgment in these cases because, by the efflux of time, admissions have been closed by 15.11.2022; and this is affirmed by all learned counsel.

3. That said, by an order dated 02.09.2022, certain

directions were issued with respect to the inspection to be conducted by the University Grants Commission (UGC) on the various colleges in question. Subsequently, this Court had issued an

order dated 29.09.2022, which is extracted as under:

Since Sri.S.Krishnamoorthy - learned Standing Counsel for the University Grants Commission (UGC), submits that his client has already granted approval to seven courses as below to the Sree Narayanaguru Open university ('Open University', for short), prima facie, the other Universities can only be allowed to conduct courses other than them.

2. Of course, the question whether the

other Universities in Kerala can conduct those courses for which the Open University has been granted approval by the UGC can be decided only after a detailed hearing of these writ petitions.

3. As matters now stand, however, as I have

said above, only those courses to which the UGC has not granted approval to the Open University can the other Universities stake claim. The said courses are as under: i. Bachelor of Arts(Combination of 3 subjects)(Sanskrit) ii. Bachelor of Arts(Combination of 3 subjects)(Hindi) iii. Bachelor of Arts(Combination of 3 subjects)(Arabic) iv. Bachelor of Arts(Combination of 3 subjects)(Malayalam) v. Bachelor of Arts(Combination of 3 subjects)(English) vi. Master of Arts (Malayalam) Vii. Master of Arts (English)

4. Resultantly, as an interim measure, I permit

the other Universities in Kerala to invite applications and begin courses, subject to them having obtained approval for such purpose from the UGC, with respect to the courses other than those which are mentioned above. List this matter for further consideration on 31.10.2022.

4. Since admissions have been now closed and neither the

students nor the teachers can obtain any relief for this year, I am of the firm view that nothing remains in these Writ Petitions for consideration on their merits as at present.

5. Of course, this Court is fully cognizant that there is

challenge mounted to certain Statutory provisions, which allegedly grants monopoly to the Sree Narayanaguru Open University. However, as I have already said above, these issues are no longer relevant this year and if the petitioners have any further cause for grievance, they certainly have to approach this Court at the appropriate time. Thus leaving open all contentions to be impelled and pursued by any person in future, I close these Writ Petitions confirming the afore extracted interim order.
