J U D G M E N T

A.Muhamed Mustaque, J.

The Kerala Public Service Commission issued a notification dated 14/12/2017 inviting application for the post of Medical Officer (Ayurveda)/Assistant Insurance Medical Officer (Ayurveda). In the notification it is specifically stated that 3% of the vacancies are reserved for differentially abled candidates. The category of differentially abled candidates is also mentioned in the notification. In the note it

was mentioned that for the category of Medical Officer (Ayurveda), differentially abled candidates with locomotor disability/cerebral palsy are eligible -:16:- and; in the category of Assistant Insurance Medical Officer (Ayurveda), differentially abled candidates with locomotor disability/cerebral palsy, blindness, low vision are eligible for reservation. The shortlist of eligible candidates was published on issued by including low vision category for 3% reservation in the ranked list of Medical Officer (Ayurveda). Erratum notification was based on the decision of the Government dated 26/11/2018 to include low vision category of disabled persons for appointment as Medical Officer (Ayurveda). This was based on the proceedings dated This erratum notification was challenged before the Kerala Administrative Tribunal. The challenge was at the instance of the candidates who are coming under the category of orthopeadically handicapped person (loco motor disability) who are included in the ranked list for appointment for the post of Medical Officer (Ayurveda). The Tribunal repelled the challenge.

2. Heard the learned Senior Counsel Dr.K.P.Satheesan for

the petitioners, learned Standing Counsel Shri P.C.Sasidharan for the PSC, learned counsel Shri V.V.Nandagopal Nambiar and Shri -:17:- Roshan D.Alexander appearing for the party respondents and the learned Senior Government Pleader Shri Saigi Jacob Palatty.

3. The learned Senior counsel arguing on behalf of the

petitioners submits that the PSC is precluded from including new category of persons in the final ranked list after the selection process is over. The learned Senior Counsel further submits that

the Government itself had deprecated such a procedure in its order

dated 7/8/2020 and, therefore, the subsequent identification of category of low vision candidates after the publication of the ranked list for appointment to the post of Medical Officer (Ayurveda) can operate only for future notifications.

4. The learned Standing Counsel for the PSC, the learned

counsel for the party respondents and the learned Government Pleader argued that it is not the Government Order that gave rise to the inclusion of low vision candidates for the Medical Officer (Ayurveda) but based on the statutory provision as referable under the Rights of Persons with Disabilities Act, 2016 (hereafter referred to as the Act 2016).

5. The learned Senior Counsel Dr.K.P.Satheesan placed

reliance on the following judgments to buttress his argument that -:18:- the criteria for selection cannot be altered after the selection process commenced. i. K.Manjusree v. State of A.P. and Another [2008 KHC 4283] ii. Zonal Manager, Bank of India, Kochi and Others v. Aarya K.Babu and Another [2019 KHC 6778]

6. We, at the outset, hold that these judgments have no

relevance in these matters. It is not a case where the criteria for eligibility being altered after the notification or after the publication of the ranked list. The candidates now included in the category of low vision for the post of Medical Officer (Ayurveda) are equally eligible, in the light of the eligibility criteria fixed in the notification. The question is whether they are eligible or not for reservation based on the subsequent identity of their category as a separate category for reservation.

7. It is to be noted that the candidates included in the

ranked list have no indefeasible right for appointment. They are only entitled for consideration for advise in accordance with the existing rules. The inclusion of a particular category or non- inclusion of such a category falls in the domain of State policy. -:19:- When State Policy resonates statutory provision, that itself gives rise to those persons to demand such reservation as a matter of right. Equal opportunity and equal access to employment are the facets of the fundamental rights under the Constitution. Act 2016 reinforce the Constitutional ethos. The statutory provisions only gave meaning to that Constitutional ethos by setting out procedure and identification of categories of differently abled persons. Once the statute recognizes the fundamental rights of equal opportunity by delineating a

procedure, no notification can withhold a person from claiming such a right. That means no one can question the right of such persons for equality of opportunity. The Constitutional ideals to become workable, there may be a requirement to have statutory provisions or executive orders and, that statutory provision or executive order actually is galvanising the Constitutional right into action. Had it not been done by the Government by appointing an Expert Committee to identify the category, this ought to have been subject matter of another litigation at the instance of low vision candidates for inclusion. The Expert Committee having found that such category of persons also can be appointed as Medical Officer (Ayurveda), no judicial review is possible to overturn such identification. Then - :20:- the Government and PSC is bound to identify such category of persons for the current notification as well. Even going by the objectives under Section 34(2) of the Act 2016 and the object of the enactment from 1996 onwards, would enable such low vision candidates to demand for reservation with reference to backlog vacancies as well. That be the case, the Tribunal rightly rejected the challenge. There is no merit in the original petitions. The original petitions fail and are dismissed.
