JUDGMENT

These three writ petitions are connected and therefore, I am disposing of these three writ petitions by a common

judgment.

2. W.P.(C).No.37309/2022 is filed with the following prayers;

i Issue a writ of certiorari or any other appropriate writ order or direction setting aside Ext.P2 to the extent of fixing the ceiling limit for enhancement of DCRG from Rs.14 lakhs to Rs.17 lakhs as 01.04.2021.

ii. To issue a writ of mandamus or any other appropriate writ order of direction directing the respondents to fix the cut off date for enhancement of the DCRG from Rs.14 lakhs to Rs.17 lakhs from 01.07.2019 and to

direct the respondents to sanction and pay the arrears of DCRG to the petitioners with all other consequential benefits with interest at the rate of 18% p.a. from the date of superannuation of the

petitioners till the date of disbursement. iii. To declare that Rule 68 of Part II KSR to the extent it limits the maximum amount of gratuity to Rs.7 lakhs is unconstitutional. iv. Issue such other order or direction as this

Hon'ble Court may deem fit and proper in the facts

and circumstances of the case. [SIC]

3. W.P.(C).No.40570/2022 is filed with the following prayers;

i. To issue writ of certiorari or other appropriate writ, order quashing Exts.P4, & P5 to extend of denial of maximum ceiling amount of DCRG covered under Ext.P2 as it is illegal, arbitrary and unjustifiable. ii. To issue a writ of mandamus or any other appropriate writ or order or direction, directing the respondents to authorize/sanction the enhanced amount of DCRG of Rs.17,00,000/-(Seventeen Lakhs) as stated in Rule 6 of Ext.P2 as the petitioner is eligible for the same. iii. To declare that the petitioner is entitled to get the benefit of enhanced DCRG covered under Ext.P2 since the revision of pension and other related benefits consequent on the revision has been granted with effect from 01/07/2019 to the petitioner and he became pensioner on 01/04/2021. iv. To declare that the petitioner is eligible for the ceiling on maximum amount of DCRG as he was in service as on 01/07/2019, the date of effect of pay revision 2019 and he retired availing all the benefits covered in the pay revision order except enhanced DCRG. v. To declare that the cut off date fixed in Rule 6 of Ext.P2 by the 1 st respondent is illegal and arbitrary as it is against the policy of pay revision

order 2019.

vi. To dispense with filing of translation of vernacular documents. vii. To grant such other reliefs, as this Hon'ble Court shall deem just and proper in the interest of justice, including costs. [SIC]

4. W.P.(C).No.32745/2022 is filed with the following prayers;

i. Issue a writ of certiorari or any other appropriate writ order or direction setting aside the Ext.P2 to the extent of fixing the ceiling limit for enhancement of DCRG from Rs.14 lakhs to Rs.17 lakhs as 01.04.2021.

ii. To issue a writ of mandamus or any other appropriate writ order of direction directing the respondents to fix the cut off date for enhancement of the DCRG from Rs.14 lakhs to Rs.17 lakhs from and pay the arrears of DCRG to the petitioners with all other consequential benefits with interest at the rate of 18% p.a. from the date of superannuation of the

petitioners till the date of disbursement. iii. To declare that Rule 68 of part III KSR to the extent it limits the maximum amount of gratuity to Rs.7 lakhs is unconstitutional. iv. Issue such other order or direction as this

Hon'ble Court may deem fit and proper in the facts

and circumstances of the case. [SIC]

5. The petitioners in these writ petitions were retired from service during the period from 01.07.2019 to

31.03.2021. As per clause (6) of Ext.P2 pay revision order

ceiling on death cum retirement gratuity is fixed. As per clause (6) ceiling on maximum amount of DCRG will be raised from 14 lakhs to 17 lakhs with effect from 01.04.2021. According to the petitioners, they are entitled the above benefits. Subsequently, the writ petitions were amended and the petitioners contended that in the light of the division bench judgment of this Court dated 16.08.2017 in W.A.No. No.1569/2017 and judgment dated 08.01.2008 in W.A. No.1062/2003, the petitioners are entitled gratuity as per the Payment of Gratuity Act. Therefore, the petitioners submitted that they are confining their relief for getting gratuity in tune with the Payment of Gratuity Act.

6. Heard the learned counsel for the petitioners and the

learned Government Pleader. The point raised by the petitioners is considered by this Court in judgment dated 08.01.2008 in W.A.No.1062/2003. It will be better to extract the relevant portion of the above judgment and the same is extracted hereunder;

(15) Section 14 of the Payment of Gratuity Act provides that the provisions of the Act shall have affect notwithstanding anything inconsistent therewith contained in any enactment other than the Act or in any instrument or contract having effect by virtue of any enactment under the Act. The sweep of this section clearly provides that the right to claim gratuity by an employee under the provisions of this Act is not based on any contract, but a right which arises out of the provisions of the statute itself. The Apex Court in the case of Municipal Corporation of Delhi Vs. Dharam Prakash Sharma (AIR 1999 SC 293) has

held that the Payment of Gratuity Act, 1972 being a

special provision, shall have an overriding effect over any scheme that might have been adopted by the concerned employer, and even if the benefit is availed of under the concerned scheme, the employee would be entitled for payment of gratuity under the Act.

7. The above judgment was relied by this Court in W.A.No.1569/2017, and the relevant portion of the

judgment is extracted hereunder;

9. The second contention canvassed before us is that, since the Calicut University First Statutes provide that the pensionary benefits due to teachers including Family Pension and DCRG shall be governed by the provisions of Part III KSR as amended from time to time, the respondent would be entitled to claim gratuity only subject to the limit stipulated by

the said provisions. However, the above contention has to fail for more reasons than one. In the first place, as rightly contended by the counsel for the respondent Section 14 of the Gratuity Act has provided an overriding effect to the provisions of the Gratuity Act in the following words:-

14. Act to override other enactments,

etc.-The provisions of this Act or any rule made thereunder shall have effect notwithstanding anything inconsistent therewith contained in any enactment other than this Act or in any instrument or contract having effect by virtue of any enactment other than this Act.

10. A Division Bench of this Court has considered the effect of the above provision in the context of Part III KSR in relation to an employee of the Kerala State

Electricity Board (KSEB for short). As per the said judgment

(Exhibit P4 in the Writ Petition) dated 08.01.2008 disposing of W.A.No.1062 of 2003 and W.A.No.1938 of 2004 speaking for the Bench, Dattu CJ (as he then was) has held as follows:

15. Section 14 of the Payment of

Gratuity Act provides that the provisions of the Act shall have effect notwithstanding anything inconsistent therewith contained in any enactment other than the Act or in any instrument or contract having effect by virtue of any enactment under the Act. The sweep of this Section clearly provides that the right to claim gratuity by an employee under the provisions of this Act is not based on any contract, but a right which arises out of the provisions of the Statute itself. The Apex Court in the case of Municipal Corporation of Delhi Vs. Dharam Prakash Sharma (AIR 1999 SC 293) has held that the Payment of Gratuity Act, 1972 being a special provision. shall have an overriding effect over any scheme that might have been adopted by the concerned employer, and

even if the benefit is availed of under the concerned scheme, the employee would be entitled for payment of gratuity under the Act.

In view of the above, we find that the learned Single Judge has rightly allowed the claim of the respondent. Another contention put forward is that, the definition of "employee" under Section 2(e) of the Act excludes a person who holds a post under the State Government. Therefore the respondent who is paid salary by the State should be excluded. The respondent was admittedly

working as a teacher in a private aided college. Therefore, she cannot be considered to be a person who was holding a post under the State Government. It is true that, the State Government is paying the salary of the teachers of the Private Aided Educational Institutions under the Direct Payment System. However, that by itself cannot and does not bring a person like the respondent within the scope of exclusion contained in Section 2(e). The provision excludes only a person who holds a post under the State Government. The learned Single Judge has rightly found that teachers of aided private colleges are not appointed by the Government but, by the Management. Such appointments are only approved by the University later on. For the reason that the salary is paid by the Government, it cannot be held that persons like the respondent are holding posts under the State Government. For the foregoing

reasons, we find no grounds to interfere with the judgment

appealed against. The Writ Appeal fails and is accordingly dismissed.

8. I am of the considered opinion that, the above

principle laid down by this Court is applicable to the petitioners in these cases also. They are entitled DCRG as per Payment of Gratuity Act. Therefore, these writ petitions are allowed in the following manner.

1. It is declared that the petitioners are entitled DCRG as per the Payment of Gratuity Act.

2. The eligible DCRG to the petitioners as per the

Payment of Gratuity Act shall be disbursed to the petitioners, as expeditiously as possible, at any rate, within a period of three months from the date of receipt of a copy of the judgment.

3. Petitioners are entitled the statutory interest as

per the Payment of Gratuity Act also. Sd/- P.V.KUNHIKRISHNAN JUDGE saap
