3. The learned Government Advocate (Crl.Side) appearing for the

respondent police reiterated the prosecution case and opposed to allow this petition. 4. Being satisfied with the reasons stated by the petitioner, this Court is inclined to modify the condition to the effect that the petitioner shall appear before the respondent police on every Saturday at 10.30a.m., for a period of six weeks. The other conditions imposed by the Court shall remain intact.

5. With the above modification, this Criminal Miscellaneous Petition is ordered.
