that pursuant to the order of the Full Bench of this Court in the case of P.Venkatachalam and Others vs. The Tahsildar, Kumarapalayam Taluk and Others, reported in 2022 4 CTC 1, a Government Order in G.O.Ms.No.478 dated 29.09.2022 was issued, which provides the procedure to deal with the issuance of legal heir certificate including the appellate mechanism. He would further submit that the petitioners request would be considered keeping in view the above Government Order.
