JUDGMENT

Heard party-in -person.

2. After much chequered career in the case, the petitioner had approached the Hon'ble Supreme Court through Civil Appeal Nos. 7295 to 7295 of 2013. All the said Civil Appeals were disposed of vide judgment dated 29.08.2013, wherein it was held: "We appreciate the stand taken by the Respondent No.1-Canara Bank that they do not propose to recover any further amount from the appellant. Further, it was also submitted that the amount O.P.(C) 862 of 2015 -:

2. :- already recovered would amount to full and final satisfaction of the decree. Under the above circumstances, all the disputes between the appellant and Canara Bank would stand closed, and the proceedings, if any, pending before any forum would stand withdrawn and allegations raised against the Canara Bank and its officials would stand expunged." 3. In the light of the said judgment, it seems that the entire disputes between the petitioner and the Canara Bank have come to an end and the same cannot be reopened. As held by the Apex Court, all disputes between the petitioner and Canara Bank would stand closed. Further, the Apex Court has ordered that the proceedings, if any, pending before any forum between these two parties would stand withdrawn and the allegations raised against the Canara Bank and its officials would stand expunged. Matters being so, the present request forwarded by the petitioner cannot O.P.(C) 862 of 2015 -:

3. :- be entertained at present by this Court. In the result, I.A.7361/2015 and the Original Petition are dismissed. Sd/- B.KEMAL PASHA, JUDGE ul/- [True copy]
