2/19.06.2013 Anticipatory bail application filed by Labu Sk., Raffijuddin Sk. @
Rabijuddin Sk., Fitu Sk. @ Abdul Rashid, Aji Jul Sk. and Ahbedu Sk. is moved by
Mrs. Nitu Sinha, learned counsel for the petitioners and opposed by Sri V.K.
Tiwary, learned Additional PP. for the State. It is alleged that petitioner No. 1
namely Labu Sk. was in possession of a fire arm. Under the said circumstances, I
am not inclined to enlarge petitioner No. 1 namely Labu Sk. on anticipatory bail.
Accordingly, his anticipatory bail application rejected. So far other petitioners

namely Raffijuddin Sk. @ Rabijuddin Sk., Fitu Sk. @ Abdul Rashid, Aji Jul Sk. and Ahbedu Sk. are concerned, no fire arm found in their possession. Considering the aforesaid facts and circumstances, I allow the anticipatory bail application of petitioner Nos. 2

4. and 5 namely Raffijuddin Sk. @ Rabijuddin Sk., Fitu Sk. @ Abdul Rashid, Aji Jul Sk. and Ahbedu Sk. and direct them to surrender in the court below on or before 29th of June 2013 and in the event of their surrender, the learned court below is directed to enlarge them on bail on furnishing bail bond of Rs. 10,000/- (Ten Thousand) each with two sureties of the like amount each to the satisfaction of learned S.D.J.M. Pakur, in connection with Pakur (M) P.S. Case No. 37 of 2013, corresponding to G.R. No. 116 of 2013, subject to the condition as laid down under section 438(2) of the Cr. P.C. (Prashant Kumar, J.) Binit
