25. 01-2012 Heard learned counsel for the petitioner and learned counsel for the State. The petitioner has been arrested in connection with Gopalpur (Rangra) P.S. Case No. 101 of 2011, registered under Sections 498 A, 323 and 504/34 of the Indian Penal Code and Section 3/4 of Dowry Prohibition Act. This case with regard to offence under Section 498 A of the Indian Penal Code. The petitioner is in custody since 15. 07. 2011. Having regard to the facts and circumstances of the case, the above named petitioner is directed to be released on bail on furnishing bail bond of Rs. 10,000/- (Ten thousand) with two sureties of the like amount each to the satisfaction of the S.D.J.M, Naugachhiya, Bhagalpur, in connection with Gopalpur (Rangra) P.S. Case No. 101 of 2011, subject to condition that petitioner

No.2958 of 2012 (2) dt.25-01-2012 every date fixed by the court below and in any absence subject to reasonable ground to the satisfaction of the court below and the case shall be proceeded on day to day basis for earlier disposal of the case.
